### **Source 1: The Cellular Scramble**

Several schools have launched "bring your own technology" programs this year. Parents and students rely on cell phones to keep in touch in case plans change after school. An eighth grader from Yorktown Heights, N.Y., agrees. "We should be able to carry our cell phones in school because we may need to contact our parents in emergencies," she says.

## Source 3: No Cell Phones, No Problems

Cell phones can be a major distraction that disrupts student learning. Schools should ban cell phones so students can focus more on their academic education.

Students can use cell phones to chat, surf the internet, and listen to music. All those things can distract students during the school day. According to a 2010 study, 64 percent of kids with cell phones have sent texts during class. Those texts are most likely distracting kids from their studies.
